This year has been a year of transition for our United Way. Under the leadership of our Campaign Chair Michael Angelucci and the generosity of over 667 donors, we exceeded our campaign goal by over \$22,000 and raised more than \$442,539.

Our funded agencies are doing tremendous work in our community. Last year, they helped 22,000 Marion County residents achieve better health, deeper education, and stronger financial stability.



Empty Bowls

The third annual Empty Bowls Soup and Bread Luncheon was held on April 9th at the Knights of Columbus. The event was the largest one yet and raised over \$6,400 for the Soup Opera, Connecting Link, and Salvation Army.

Over 400 people attended and enjoyed a meal and education about hunger in our community. Each attendee took home a handcrafted bowl that was donated by local artisans and businesses. All the soup, desserts, and bowls were donated by generous individuals and businesses in our community. The event is a true community collaboration. The 2018 event will be March 11, 2018.



Stuff the Bus



United Way joined with Mon Power and the MVA Fairmont Clinic to sponsor our first Stuff the Bus collection. While many are focused on school supplies, our drive collected food and personal hygeine items for the local school pantries. Many of these pantries are completely funded by teachers and do not have enough resources to help their students.

The items were collected at two locations in Fairmont and then sorted and delivered to each of the schools. Fourteen schools partnered with the event and United Way was able to provide supply grants to each of them with the dollars raised from the event.

Special thanks to the Marion-Fairmont Transit Authority for their use of a bus to aid the collections.

Cheerleading Clinic

On June 3rd, United Way sponsored a free Cheerleading Clinic for ages 5-14 at the Feaster Center on Fairmont State University's campus.

Attendees learned cheer motions, jumps, tumbling, stunts, and life skills from volunteer Cheer Coaches. The attendees all walked away with new routines to take back to their schools and to help with their future development.

Over 40 local children attended the clinic.




