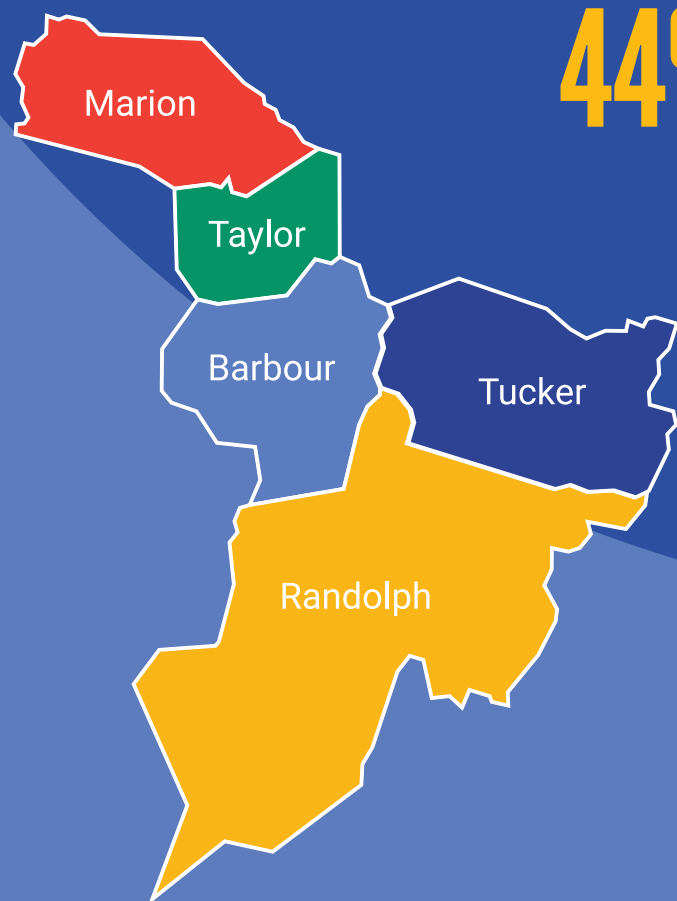

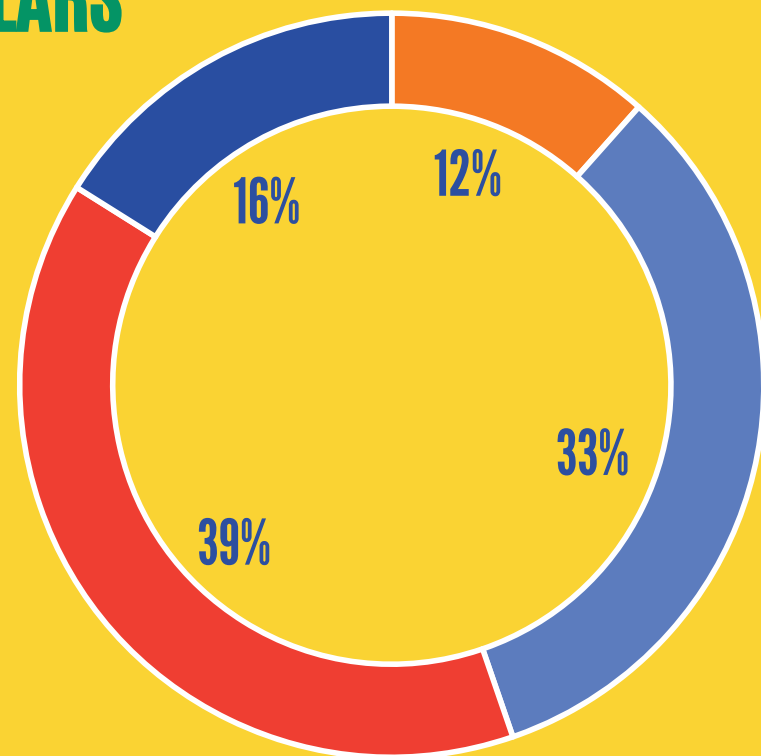

WV 211 is our free and confidential hotline that connects area residents to critical resources when they need help the most. Our statewide database has over **11,400** available resources. It is available **24** hours a day, **365** days a year. Get Connected. Get Help!

Last year, our operators made **120,883+** connections for individuals in need.



VITA (Volunteer Income Tax Assistance) is our free tax preparation program that helps individuals file their state and federal taxes for free.

This year, our **5** sites prepared **1,286** tax returns and helped save families across **13** counties more than **\$450,100** in tax preparation fees.



United for Kids is our community-wide collection to help young people in all five counties have what they need to face their day with dignity. The drive provides items to stock the hygiene pantries at each individual school.

This year, we were able to provide supplies to **all 50 schools** across the five-county region.

DISASTER RESPONSE



When devastating floods struck our region, Tygart Valley United Way **responded immediately** – not just with words, but with action. Thanks to the incredible support of our donors, partners, and volunteers, we launched a comprehensive Flood Assistance Fund to meet both the urgent and long-term needs of our community.

In the first days after the disaster, we **mobilized** quickly to establish donation distribution centers across affected counties, ensuring that families had access to essential supplies – including clothing, hygiene items, cleaning materials, and bottled water. With the help of more than 100 volunteers, thousands of items were sorted, packed, and delivered to those in need.

As the waters receded, our work expanded to support **long-term recovery**. We helped connect individuals with critical services, supported flood survivors in replacing vital documents, and began coordinating with partner agencies to assist with housing, case management, and other recovery needs.

Our response was swift, but our commitment is ongoing. Tygart Valley United Way remains dedicated to standing with our neighbors through every stage of recovery, proving once again that **United is the Way**.
